

Weatherization helps households by installing multiple energy efficient measures such as attic, wall, floor, water pipe and duct insulation, replacing windows and doors, as well as improving the safety of the home by performing heating system improvements and mechanical ventilation. CDCAC provided utility assistance to 1316 households in 2021 paying for electricity, propane, natural gas, wood and other sources of heat.
